Thanks to your ongoing support and unwavering commitment, the Chronicle Season of Sharing Fund has had another phenomenal year.

The 2008-09 campaign raised more than \$5.6 million, a new all-time record and the third consecutive year the campaign has exceeded the \$5 million fundraising mark. This incredible success during troubled economic times is a true testament to your genuine dedication to helping others.

Over the last 23 years the Chronicle Season of Sharing Fund has distributed more than \$66 million to help Bay Area residents in need. During 2008-09 we distributed over \$4.6 million to resolve critical family needs and housing assistance issues and distributed over \$800,000 to food banks.

Your donations play a significant role in helping to reduce homelessness and hunger in the Bay Area. The number of families struggling to find a decent meal, stay in their homes or receive the medical attention they need has increased dramatically over the past 12 months. The needs of our communities are great and have continued to grow as a result of the struggling economy. It is also no surprise that the number of individuals we assisted who were laid off from their jobs was alarmingly greater than it has been in the past.

The Season of Sharing Fund had a daily presence in the San Francisco Chronicle from Thanksgiving Day through New Year's Day. The 2008-09 campaign highlighted stories of the challenges our neighbors faced throughout the year. These stories underscore the fact that the need for our assistance is constant, occurring not just during the holiday season but lasting all year long.

The Chronicle Season of Sharing Fund is dedicated to stabilizing the lives of individuals and families in the Bay Area. Your contributions provide us with the means to make a positive difference in the lives of the people who need it most. We are especially proud that we still distribute 100 percent of the money we raise back into Bay Area communities. All administrative costs are covered by The Chronicle, interest generated by the Fund and support from the Evelyn and Walter Haas, Jr. Fund.

The San Francisco Chronicle covers the remaining 2.5%, in addition to paying \$36,000 to the nine County Coordinating Agencies (\$4,000 per county).
